PUBLIC HEARING AND ADOPTION ON ORDINANCES/NEW BUSINESS:

<u>21-30</u>(Public Hearing Held) An ordinance amending ordinance 21-15 relative to the annual operating budgets for St. John the Baptist Parish, for the fiscal year beginning January 1, 2021 and ending December 31, 2021(J. Hotard)

MOTION: Councilman Wright moved and Councilman Madere seconded the motion to approve Ordinance 21-30. The motion passed with 8 Yeas and 1 Nay (Duhe-Griffin).

21-31 (Public Hearing Held) An ordinance amending Chapter 2, Section 2-21, of the St. John the Baptist Parish Code of Ordinances to establish and define the St. John the Baptist Parish Precinct Boundaries, Merge Precincts, and Establish Precinct Polling Places (K. Becnel)

<u>MOTION:</u> Councilwoman Houston moved and Councilman Wright seconded the motion to approve Ordinance 21-31. The motion passed with 7 Yeas, 1 Nay (Duhe-Griffin) and 1 Against (Schnyder).

Kurt Becnel - Resolution - R21-114 - This resolution confers authority upon the President/Vice-President or Treasurer of the Library Board of Control for St. John the Baptist Parish to execute a construction manager at risk agreement on behalf of the Board with The Lemoine Company to provide construction manager at risk services for the Reserve Branch Library Build Project

MOTION: Councilman Malik moved and Councilwoman Houston seconded the motion to approve Resolution-R21-114-This resolution confers authority upon the President/Vice-President or Treasurer of the Library Board of Control for St. John the Baptist Parish to execute a construction manager at risk agreement on behalf of the Board with The Lemoine Company to provide construction manager at risk services for the Reserve Branch Library Build Project. WHEREAS, Article IV, Section H (2) and (5) of the St. John the Baptist Parish Home Rule Charter permits the Parish Council to adopt a resolution when authorizing a designated person(s) to execute a previously approved contract on its behalf and/or to perform a ministerial act related to the administrative business of the Parish; and WHEREAS, the Parish Council authorized the St. John the Baptist Parish Library to advertise a Request for Qualifications(the "RFQ")for Construction Manager at Risk Services for the project referred to as the St. John the Baptist Parish Library Reserve Branch Library Highway 44 (River Road) between W. 4th and W. 5th Street Reserve, Louisiana; and WHEREAS, the St. John the Baptist Parish Library advertised the RFQ in accordance with Louisiana Public Bid Law; and WHEREAS, the RFQ established a committee (the "Selection Review Committee") to review and evaluate the proposals submitted in response to the RFQ; and WHEREAS, the St. John the Baptist Parish Library received two proposals in response to the RFQ; and WHEREAS, the Selection Review Committee reviewed all of the proposals received in response to the RFQ; and WHEREAS, the Selection Committee interviewed all of the proposers who submitted proposals in response to the RFQ; and WHEREAS, based on its review and evaluation of the proposals as well as its interview of the proposers, the Selection Review Committee has recommended that the Parish Council authorize the award of the contract for Construction Manager at Risk Services for the project referred to as the St. John the Baptist Parish Library Reserve Branch Library Highway 44 (River Road) between W. 4th and W. 5th Street Reserve, Louisiana to The Lemoine Company; and WHEREAS, the Parish Council wishes to ratify the recommendation of the Selection Review Committee and authorizes the St. John the Baptist Parish Library to enter into a contract with The Lemoine Company to provide Construction Manager at Risk Services for the project referred to as the St. John the Baptist Parish Library Reserve Branch Library Highway 44 (River Road) between W.4th and W.5th Street Reserve. The motion passed unanimously.

Rene Pastorek - Resolution - R21-124 - A Resolution of support for the 2021 Hazard Mitigation Plan Update

MOTION: Councilman Madere moved and Councilman Wright seconded the motion to approve Resolution - R21-124 - A Resolution of support for the 2021 Hazard Mitigation Plan Update. WHEREAS, Hazard mitigation planning reduces loss of life and property by minimizing the impact of disasters; and WHEREAS, the Federal Emergency Management Agency (FEMA) requires an update to the Hazard Mitigation Plan every 5 years; and WHEREAS, the Community Rating System program recognizes and encourages community floodplain management practices that exceed the minimum requirements of the National Flood Insurance Program (NFIP); and WHEREAS, these practices result in flood insurance discounts for residents of St. John the Baptist Parish; and WHEREAS, an enhanced Hazard Mitigation Plan Update process that involves the public and follows the recommended Community Rating System practices for Floodplain Management Planning will result in additional points towards that discount. Now, therefore: THE ST. JOHN THE BAPTIST COUNCIL HEREBY RESOLVES: That the Parish hereby supports the 2021 Hazard Mitigation Plan Update planning process. The motion passed unanimously.
