The Council of the Parish of St. John the Baptist Parish, State of Louisiana, met in Regular Session in the St. John the Baptist Parish Government Complex Chambers, LaPlace, Louisiana on Tuesday, July $27^{\rm th}$, 2021, at 6:30 PM.

CALL TO ORDER:

<u>Kurt Becnel - Presentation - Andrea J. Hollins - Selah Productions, Inc. - JaVon</u> Ophelia's ACT Mentorship & Learning for the Performing Arts Program

JaVon Ophelia Butler and Andrea J. Hollins were present to share information on the program JaVon Ophelia's ACT. The program is funded through sponsors to assist with training students, children, youths, adults, acting, singing, and dancing.

Rene Pastorek - Presentation - Cost Benefit Analysis and Evaluation of Code Compliance Program

Rene Pastorek stated, "Thank you Chairman. In accordance with the CEA, between the Parish and South Central Planning for the Building Code Compliance Program, a formal presentation is required to be presented to the Council with the results of an analysis of the benefit to the Parish that this program provides before the Council can consider an extension of this agreement. This extension will be placed to the Council for consideration at the next council meeting. In July 2021, Vermillion Marketing and Opinion Research conducted a cost benefit analysis of the contract, to determine savings and benefits to the parish. The Consultant analysis savings realized by contracting with South Central Planning, instead of performing the services with an inhouse program. The Consultant also determines that contracting these services through a private third-party, is not feasible and would be more expensive to the parish. Giving current budgets, salaries, trainings, certifications, and equipment needs to run this type of program, the parish sees an annual savings between a hundred thousand (\$100,000) and two hundred thousand dollars (\$200,000) per year under the current contract with South Central Planning. This is an increase in savings since the original contract was signed in 2018."

DEPARTMENT/ENGINEER REPORTS:

<u>Thomas Malik - Glen Dottolo - Discussion regarding Fireworks in Residential</u> neighborhoods

"Good evening, my name is Glen Dottolo I lived in LaPlace most of my life. I'm asking the Council to consider a ban on the sale and use of fireworks to individuals. An exemption would apply to church, or civic organizations under permit with the supervision of the sheriff department or fire department. The illegal and reckless discharge of fireworks, every holiday it's a threat to public safety and property. Here are a few reasons supporting this proposal: #1) Fireworks are being used as a cover for the illegal discharge of guns. My son is an Army Veteran, and Policeman and has said the rapid sequence in acoustics are clearly distinguishable as gunfire. #2) Powerful explosives such as M80s are being discharged in drainpipes, which amplify sound and the potential for cracks and structural damage. My son said it sounds like throwing a grenade into a cave bunker. #3) Our quality of life is infringed, when sleep is interrupted and dogs are barking in fear. This borage lasted past 2 AM, Friday through Monday night this past 4th of July weekend. Permitted time frames are ignored and enforcement by the sheriff's department is nearly impossible. A few irresponsible people are responsible for this mayhem. This is not kids or families using sparklers or bottle rockets, you will not see burst in the sky, and is very hard to pinpoint the location as a result. My neighbors and I strongly urge the Council, to ban fireworks in the parish. We're one of the very few parishes in the Metro area that permit the sale and use of fireworks. I ask you why? Is if for the permit fees and sales taxes? What are the compelling reasons not to ban fireworks? There are enough problems in the parish, we can fix this one. Thank you."
