NOW, THEREFORE, BE IT RESOLVED, by the St. John the Baptist Parish Council, that St. John the Baptist Parish is hereby authorized to renew the cyber liability insurance coverage with Travelers Casualty and Surety Company of America. authorized St. John Parish Administration to award the bid for the 2020 Parish wide Street Ditch Drainage Improvements to On-Grade Construction, LLC: and WHEREAS, as of November 2020, On-Grade Construction, LLC has been non-responsive to several communication attempts both phone, email and in person made by the Parish engineer to begin construction the last attempted correspondence being May 6, 2021: and WHEREAS, as per the recommendations of the Parish Consultant Engineer, St. John the Baptist Parish is requesting to terminate the agreement with On-Grade Construction, LLC for cause; and WHEREAS, as outlined in the agreement, St. John the Baptist Parish "may terminate for cause based upon the failure of the contractor to comply with the terms and/or conditions of [the] agreement". NOW, THEREFORE, BE IT RESOLVED, by the St. John the Baptist Parish Council, that St. John the Baptist Parish is hereby authorized to terminate for cause the agreement with On-Grade Construction, LLC for the 2020 Parish wide Street Ditch Drainage Improvements. The motion passed with Councilman Wright absent.
