SUBSTITUTE MOTION: Councilman Arcuri moved and Councilwoman Houston seconded the substitute motion to amend Ordinance 24-06 to read. An ordinance that submits a proposed amendment to the St. John the Baptist Parish Home Rule Charter to the qualified electors, in accordance with Article VIII, Section C - Election. WHEREAS, on Tuesday, November 4, 1980, the qualified electors of the St. John the Baptist Parish approved the St. John the Baptist Parish Home Rule Charter (the "Charter"). WHEREAS, subsequent amendments to the Charter were made pursuant to special elections held Saturday, July 20, 1996, and Tuesday, November 5, 1996. WHEREAS, Article III, Section A 2. Compensation of the Charter details the process to adjust the compensation of councilmembers. WHEREAS, Article III, Section A 2. Compensation of the Charter currently provides for the following: The members elected by districts and divisions shall receive an annual salary of \$7,200.00 payable monthly on the last day of each month. This compensation may be adjusted by ordinance passed by a two-thirds vote of the entire council. The total amount of the adjustment shall not exceed the accumulated percentages of the annual United States Bureau of Labor Statistics Consumer Price Index as computed for the preceding three years of their term. The councilmembers may only consider raising their compensation at only one meeting during their four-year term that shall be held within 30 days of the qualifying deadline for the councilmember election. In no event shall any monthly United States Bureau of Labor Statistics Consumer Price Index be used to adjust said compensation. WHEREAS, this proposed amendment amicably resolves and remediates a legal issue that is the subject of litigation in Bridget A. Dinvaut, in her official capacity as District Attorney, in and for the Fortieth Judicial District, Parish of St. John the Baptist v. St. John the Baptist Parish, St. John the Baptist Parish Governing Authority and St. John the Baptist Parish Council, 7705 "B". WHEREAS, the St. John the Baptist Parish Council shall submit this proposed Charter amendment to the qualified electors. NOW, THEREFORE BE IT ORDAINED by the St. John the Baptist Parish Council, as governing authority of St. John the Baptist Parish, State of Louisiana, that: SECTION 1. Subject to the provisions of the Home Rule Charter, the first paragraph of Article III, Section A.2 of the Home Rule Charter shall be replaced in its entirety with the following: Article III, Section A.2. Compensation. Compensation. The members elected by districts shall receive an annual salary of \$19,200.00, and the members elected at large shall receive an annual salary of \$24,000.00, payable monthly on the last day of each month. This compensation may be adjusted by ordinance passed by a two-thirds vote of the entire council. The total amount of the adjustment shall not exceed the accumulated percentages of the annual United States Bureau of Labor Statistics Consumer Price Index as computed for the preceding three years of their term. The councilmembers may only consider raising their compensation at only one meeting during their four-year term. In no event shall any monthly United States Bureau of Labor Statistics Consumer Price Index be used to adjust said compensation. SECTION 2. This Ordinance is hereby adopted in accordance with the Home Rule Charter and shall become effective only upon ratification by the electors of St. John the Baptist Parish at a special election to be called for said purpose. BE IT RESOLVED by the St. John the Baptist Parish Council, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of St. John the Baptist, State of Louisiana (the "Parish"), that: SECTION 1. Election Call. Subject to the approval of the State Bond Commission, and under the authority conferred by the Constitution of the State of Louisiana of 1974, including Article VI, Sections 5, and 22 thereof, the applicable provisions of the Louisiana Election Code, and other constitutional and statutory authority, a special election is hereby called and ordered to be held in the Parish on SATURDAY, APRIL 27, 2024, between the hours of seven o'clock (7:00) a.m. and eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit: CHARTER AMENDMENT PROPOSITION Shall the first paragraph of Article III, Section A.2. of the St. John the Baptist Parish Home Rule Charter be amended to read as follows with respect to compensation of Parish Council members: The members elected by districts shall receive an annual salary of \$19,200.00, and the members elected at large shall receive an annual salary of \$24,000.00, payable monthly on the last day of each month. This compensation may be adjusted by ordinance passed by a two-thirds vote of the entire council. The total amount of the adjustment shall not exceed the accumulated percentages of the annual United States Bureau of Labor Statistics Consumer Price Index as computed for the preceding three years of their term. The councilmembers may only consider raising their compensation at only one meeting during their four-year term. In no event shall any monthly United States Bureau of Labor Statistics Consumer Price Index be used to adjust said compensation? SECTION 2. Publication of Notice of Election. A Notice of Special Election shall be published in the official journal of the Parish once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date of the election, which Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated herein by reference the same as if it were set forth herein in full. Notwithstanding the foregoing, prior to the publication of the Notice of Election, the Secretary is

authorized and directed to make any amendments to the foregoing proposition that may be required to comply with any state or federal regulatory agencies. SECTION Canvass. This Governing Authority shall meet at its regular meeting place, the Edgard Courthouse, 2393 Hwy. 18, Edgard, Louisiana, on TUESDAY, MAY 14, 2024, at SIX O'CLOCK (6:00) P.M., and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election. SECTION 4.Polling Places. The polling places for the precincts in the Parish are hereby designated as the polling places at which to hold the said elections, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law. SECTION 5. Election Commissioners; Voting Machines. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held as provided in Section 3 hereof. All registered voters in the Parish will be entitled to vote at the special election, and voting machines shall be used. SECTION 6. Authorization of Officers. The Secretary of the Governing Authority is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the Chairman and/or Secretary of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the election. Furnishing Election Call to Election Officials. Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and Ex-Officio Parish Custodian of Voting Machines of St. John the Baptist Parish and the Registrar of Voters of St. John the Baptist Parish, as notification of the special election, in order that each may prepare for said election and perform their respective functions as required by law. SECTION 8. Application to State Bond Commission. Application is made to the State Bond Commission for consent and authority to hold the special election as herein provided, and in the event said election carries for further consent and authority to amend the Home Rule Charter. A certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application.
