PUBLIC HEARING AND ADOPTION ON ORDINANCES:

20-04 Public Hearing Held (Carry Over 03-24-20) An ordinance amending ordinance 19-49 relative to the annual operating budgets for St. John the Baptist Parish General Fund, Special Revenue Funds, Enterprise Funds, and Capital Project Funds for the fiscal year beginning January 1, 2020 and ending December 31, 2020. (J. Hotard)

Jaclyn Hotard stated, "These amendments reflect changes to estimated revenues and expenditures to actual revenues and expenditures for 2020. Administration recommends approval."

<u>MOTION:</u> Councilman Wright moved and Councilman Arcuri seconded the motion to approve Ordinance 20-04 from the agenda. The motion passed with Councilman Becnel absent.

COMMITTEE REPORTS:

Councilman Wright stated, "At this time I'll offer a motion to accept the recommendations of the finance committee."

<u>MOTION:</u> Councilman Wright moved and Councilman Malik seconded the motion to accept the recommendations of the finance committee. The motion passed with Councilman Becnel absent.

OLD BUSINESS:

There was no old business.

NEW BUSINESS:

Jaclyn Hotard - Resolution - R20-05 - (Carry Over 03-24-20) A Resolution giving preliminary approval to the issuance of not exceeding Eleven Million Dollars (\$11,000,000) of Public Improvement Refunding Bonds of St. John the Baptist Parish Sales Tax District; for the purpose of refinancing outstanding debt of the Issuer; providing certain terms of said bonds; making application to the State Bond Commission for approval of said Bonds; hiring professionals in connection therewith; and providing for other matters in connection therewith

Jaclyn Hotard stated, "The St. John the Baptist Sales Tax District (a special taxing district created and governed by the Parish Council, subject to the provisions of the Home Rule Charter) issued \$15 million in Public Improvement Sales Tax Bonds in 2010. Those bonds bear interest which are rates from 4.00% to 4.125%. In the current market, the bonds of the same maturity should have lower yields, so there is an opportunity to refund (i.e., refinance) those bonds, which will result in savings to the District. Since the debt service is paid exclusively from the 1% sales tax currently being levied, any savings realized as a result of the refunding will allow for more sales tax proceeds to be budgeted for road improvements or to support the water or sewer systems. The refunding will not extend the final maturity of the bonds. Administration recommends approval."

<u>MOTION:</u> Councilman Wright moved and Councilman Malik seconded the motion to approve Resolution - R20-05. A Resolution giving preliminary approval to the issuance of not exceeding Eleven Million Dollars (\$11,000,000) of Public Improvement Refunding Bonds of St. John the Baptist Parish Sales Tax District; for the purpose of refinancing outstanding debt of the Issuer; providing certain terms of said bonds; making application to the State Bond Commission for approval of said Bonds; hiring professionals in connection therewith; and providing for other matters in connection therewith. The motion passed with Councilman Becnel absent.

Robert Figuero - (Carry Over 03-24-20) Request adoption of the Disaster Recovery and Business Continuity for Technology Policy

Robert Figuero stated, "This policy is a new requirement from the Louisiana Legislative Auditor (LLA) in order to be in compliance with the State Agreed Upon Procedures. Administration recommends approval."

<u>MOTION:</u> Councilman Malik moved and Councilman Wright seconded the motion to grant administration authorization for the adoption of the Disaster Recovery and Business Continuity for Technology Policy. The motion passed with Councilman Becnel absent.

Stacey Cador - (Carry Over 03-24-20) Authorization to amend the St. John the Baptist Parish Employee Handbook to effectuate compliance and consistency with the St. John the Baptist Parish Home Rule Charter

Stacey Cador stated, "After a thorough review of the Employee Handbook, Administration is requesting amendments for consistency with the Home Rule Charter, to update or further clarify existing policies within. Administration recommends approval."

<u>MOTION:</u> Councilman Wright moved and Councilman seconded the motion to grant administration authorization to amend the St. John the Baptist Parish Employee Handbook to effectuate compliance and consistency with the St. John the Baptist Parish Home Rule Charter. The motion passed with 7 yeas, 1 against (Houston) and 1 absent (Becnel).
