this grant is to enable St. John the Baptist Parish to create guidelines for Garyville Historic District, LaPlace Historic District, Reserve Historic District and River Road Historic District; and, WHEREAS, in order to maintain the architectural historic integrity of the Historic Districts, the Parish's Historic District Commission feels it is necessary to have design standards professionally developed for buildings within the District by a qualified Historic Preservation Consultant; and, WHEREAS, this project will help emphasize education and public knowledge of Historic Preservation, build visibility and expand and promote Historic Preservation Services and Programs in St. John the Baptist Parish; and, WHEREAS, the Grant Funds require a 60/40 match from St. John the Baptist Parish totaling \$16,000 which will be funded through the Planning and Zoning Department. NOW, THEREFORE BE IT RESOLVED, that the St. John the Baptist Parish Council does hereby authorize the Parish President to execute, complete and submit all documents in connection with the Louisiana Division of Historic Preservation 2023-2024 Historic Preservation Fund Grant Award. The motion passed with Councilwomen Faucheux and Schnyder absent.
