REQUEST FOR PROPOSALS Repair of Submersible Pumps, Motors, and Related Equipment

BACKGROUND

St. John the Baptist Parish (herein referred to as "the Parish") hereby issues a Request for Proposals (RFP) for qualified companies (herein referred to as "Company") to provide submersible pump and motor repairs. The Parish has Water Facilities, Wastewater Facilities, Wastewater Collection Facilities and Drainage Facilities that have various pumps and motors that from time to time require repairs. These repairs could be but not limited to stator rewind, bearing replacement, o-ring replacement, wear ring repair or replacement, shaft repair or replacement and replacing the oil in the pumps and motors.

SCOPE OF WORK

It is the intention of St. John the Baptist Parish to award a contract to the company(s) with the proposal that will provide the best service to the parish. The selected Company(s) will work closely with the Parish Utilities Department and other administrative staff to provide support and maintenance in various locations. The scope of work that the company must provide is stated in Exhibit A.

GENERAL TERMS AND CONDITIONS

1.0 RFP Process

- **1.1** This RFP is subject to all applicable state and local laws, including the Louisiana Code of Governmental Ethics.
- 1.2 RFP's, associated documents and addenda may be obtained from the Department of Purchasing and Procurement at 1811 W. Airline Hwy., LaPlace, LA 70068 or by downloading from the Parish's website at www.sjbparish.com or Central Bidding at www.centralbidding.com. Electronic proposals will be accepted only on www.centralbidding.com.
- **1.3** Written addenda to the RFP may be issued to provide clarification, corrections, or to answer questions. It is the Company's responsibility to periodically check either Parish website, or Central Bidding for addenda that may be issued to implement changes or clarifications to the RFP, prior to due date. **Checking the Parish website is HIGHLY recommended.**
- 1.4 The Parish reserves the right to request additional information to clarify proposals. The

Parish shall determine the appropriate means of clarification: telephone, e-mail, letter, or oral interviews.

1.5 Questions and comments regarding this Proposal must be submitted in writing to St. John the Baptist Parish, Purchasing & Procurement Department, ATTN: Peter Montz, 1811 West Airline Highway, LaPlace, LA 70068 or via e-mail to p.montz@stjohn-la.gov no later than 10:00 A.M. local time on July 9, 2025.

2.0 Submission of Proposal

- 2.1 Proposals shall be addressed to St. John the Baptist Parish and delivered to the receptionist located in the St. John the Baptist Parish Government Complex, 1811 West Airline Hwy., LaPlace, LA no later than 9:45 A.M. local time on July 17, 2025. Proposal package must be submitted in a sealed envelope or package clearly marked with the Proposer's name and address, and "RFP 2025.12 Repair of Submersible Pumps, Motors, and Related Equipment".
- 2.2 Each Proposer shall provide a submittal package based on the designated point evaluation scoring criteria. The submittal shall provide clear and sufficient information to enable the selection committee to evaluate the responsiveness and quality of the proposal. The Selection/Scoring Criteria (Exhibit D) will be used to evaluate all proposals received. Failure to provide all required information, including the "Required Signature Page for Proposals" shall be cause for rejection of the submittal as non- responsive.
- **2.3** Proposer shall submit an original, and one electronic copy of proposal by the date and time specified. Failure to submit the required number of copies may result in finding of non-responsive. Original should be clearly marked.
- **2.4** The Parish will not be responsible for submissions forwarded through the U.S. Postal Service or any delivery service if lost in transit at any time before submission opening, or if hand-delivered to the incorrect location.
- **2.5** Proposals submitted by facsimile (FAX) or e-mail will not be accepted. Any proposal received after **9:45 A.M. local time** on **July 17, 2025** will be deemed non-responsive and will be returned to proposer unopened.

3.0 Pre-Proposal Conference

4.0 Opening

Proposals will be read publicly at **10:00 A.M. local time on July 17, 2025 in** the St. John the Baptist Parish Government Complex Council Chambers, 1811 W. Airline Highway, LaPlace, LA 70068.

5.0 Public Disclosure

It is understood and agreed upon by the Proposer in submitting a proposal that the Parish has the right to withhold all information regarding this procurement until after contract award, including but not limited to: the number received; competitive technical information; competitive price information; and the Parish's evaluation concerns about competing proposals. Information

releasable after award is subject to the disclosure requirements of the Louisiana Public Records Act. Proposer specifically waives any claims against Parish related to the disclosure of any materials if made under a public records request.

6.0 Parish Commitment

- 6.1 Parish shall have the right to reject or accept any Proposal or offer, or any part thereof (i.e., any component of any proposed solution) for any reason whatsoever and to accept other than the lowest offer, at its sole discretion.
- 6.2 This RFP does not commit the Parish to award, nor does it commit the Parish to pay any costs incurred in the submission of the Proposal, or in making necessary studies or designs for the preparation thereof, nor procure or contract for services or supplies. Further, no reimbursable cost may be incurred in anticipation of a contract award.
- 6.3 The Parish reserves the right to terminate this RFP at any time prior to contract execution.
- 6.4 No prior, current, or post-award verbal conversation or agreement(s) with any officer, agent, or employee of the Parish shall affect or modify any terms or obligations of this RFP, or any contract resulting from this procurement.
- 6.5 The Parish reserves the right to revise any part of the RFP by issuing an addendum to the RFP at any time in accordance with relevant Louisiana Revised Statutes. Issuance of this RFP in no way constitutes a commitment by the Parish to award a contract. The Parish reserves the right to accept or reject, in whole or part, all Proposals submitted, and/or cancel this announcement if it is determined to be in the Parish's best interest. All materials submitted in response to this announcement become the property of the Parish, and selection or rejection of a submittal does not affect this right.

7.0 Late, Modified, or Withdrawn Proposals

- 7.1 Any proposal received after the exact time specified for receipt will not be considered.
- 7.2 No modification of a proposal, except a modification resulting from the Parish's request for "best and final offer," will be accepted.
- 7.3 No Proposer may withdraw his/her proposal within forty-five (45) days after the actual date of opening thereof.

8.0 Evaluation and Selection

- 8.1 Objective The purpose is to evaluate all proposals with the ultimate interest of entering into an agreement with that Proposer determined to be most advantageous to the Parish, price and other factors considered.
- 8.2 Evaluation A Source Selection Committee is appointed by the Parish President for the purpose of evaluating qualifications and proposals received in response to RFP. The Committee will evaluate proposals submitted by qualified Proposers/Companies on the basis of the guidelines set forth in the RFP. The Parish reserves the right to request additional information and clarification of any information submitted.

- 8.3 Evaluation criteria have been established to determine which Company/Proposer will best contribute to the overall goals of the Parish. These criteria are detailed in Exhibit C (Selection/Scoring Criteria) which is attached hereto and made a part hereof.
- 8.4 The Source Selection Committee will determine if interviews are necessary as part of its evaluation process.
- 8.5 Recommendation and Selection The Parish Administration will present its recommendation to St. John the Baptist Parish Council for award. As part of the negotiation process, the Parish reserves the right to negotiate with the successful Company. This award will be made to the most responsible Proposer whose proposal is determined in writing to be most advantageous to the Parish, based on the scoring criteria set forth in this document. The Parish also reserves the right to reject any and all proposals.

9.0 Terms

The initial contract shall begin on the date of execution and will be effective until March 31, 2026. Upon written mutual agreement between the Parish Council and the Contractor, this contract may be extended two (2) additional times for one (1) year increments. The Parish will not honor or consider any price increase, fuel surcharge, or add-on cost during the established performance or extension period. The Proposers must submit firm fixed pricing.

10.0 Insurance

Company shall obtain, pay for and keep in force, at its own expense, minimum insurance effective in all localities where Proposer/Proposer may perform the work hereunder, with such carriers as shall be acceptable to Council:

A. <u>Statutory Workman's Compensation</u> covering all state and local requirements and Employer's Liability

Insurance covering all persons employed by Proposer/company in connection with this agreement.

The limits for "A" above shall be not less than:

- 1. Employer's liability limits of \$1,000,000/\$1,000,000/\$1,000,000
- 2. Some contracts may require USL&H or maritime coverage. This should be verified with Insurance Department/Legal Dept.
- 3. No excluded classes of owners/officers or employees shall be allowed on Council's premises. WAIVER OF SUBROGATION in favor of St. John the Baptist Parish Council shall be indicated on certificate.

B. **Commercial General Liability**, including:

- 1. Contractual liability assumed by this agreement
- 2. Owner's and Proposer's Protective Liability (if Proposer is a General Proposer) may be required.
- 3. Personal and advertising liability
- 4. Completed operations
- 5. Medical payments

The limits for "B" above shall not be less than:

- 1. \$1,000,000 each occurrence limit
- 2. \$2,000,000 general aggregate limit
- 3. \$1,000,000 products/completed operations aggregate limit
- 4. \$1,000,000 personal and advertising injury limit
- 5. \$50,000 fire damage limit

6. \$5,000 medical expense limit (desirable but not mandatory)

St. John the Baptist Parish Council shall be NAMED as additional insured and WAIVER OF SUBROGATION in favor of St. John the Baptist Parish Council shall be indicated on certificate.

Some contracts may require Protection and Indemnity coverage. This should be verified with Insurance Department/Legal Dept.

C. <u>Comprehensive Automobile Liability</u> covering all owned, hired and other non-owned vehicles of the Company.

The limits for "C" above shall not be less than:

1. \$15,000/\$20,000BI/\$25,000 PD

St. John the Baptist Parish Council shall be NAMED as additional insured and WAIVER OF SUBROGATION in favor of St. John the Baptist Parish Council shall be included on certificate.

OTHER SPECIFIC COVERAGE RELATED TO THE TASK BEING PERFORMED MAY BE REQUIRED.

All required insurance certificates shall be submitted to the Director of Purchasing & Procurement prior to commencement of work. Proposer shall maintain insurance in full force and effect during the entire period of performance of work. All policies must have a thirty (30) day non-cancellation clause giving the Parish thirty (30) days prior written notice in the event a policy is changed or canceled.

D. <u>Professional Liability Insurance</u> covering the Wrongful Acts of those professional firms and individuals performing services for St. John the Baptist Parish. Certain classifications of service providers will be required to provide evidence of Professional Liability Insurance. Examples of these providers include but are not limited to: Professional Engineers, Architects, Land Surveyors, Attorneys, and IT Proposers.

The limits for "D" above shall not be less than: \$1,000,000 CSL

WAIVER OF SUBROGATION in favor of St. John the Baptist Parish Council shall be included on the Certificate.

OTHER SPECIFIC COVERAGE RELATED TO THE TASK BEING PERFORMED MAY BE REQUIRED.

All required insurance certificates shall be submitted to the Director of Purchasing & Procurement prior to commencement of work. Proposer shall maintain insurance in full force and effect during the entire period of performance of work. All policies must have a thirty (30) day non-cancellation clause giving the Parish thirty (30) days prior written notice in the event a policy is changed or canceled.

11.0 Submittals Required upon Provisional Award

Failure to provide the following documentation within the time period specified may be cause for the provisional award to be voided and the submittal to be rejected as non-responsive:

- Insurance Requirements as specified in Section 1.0, if not currently on file
- A current, fully executed Taxpayer Identification Number (W-9 form)
- A current St. John the Baptist Parish Occupational License, if applicable.
- Attestation, Non-Solicitation, Debarment and Anti Lobbing Forms

12.0 Invoices

Itemized invoices for payment of these services shall be submitted to the Director for approval prior to routing to Accounts Payable.

13.0 Hold Harmless

To the fullest extent permitted by law, Proposer shall indemnify, hold harmless, and defend the Parish Council and all of its Agents and Employees, from and against all claims, damages, losses and expenses, including but not limited to attorney's fees, arising out of or resulting from performance of the work, provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property (other than the work itself) including loss of use resulting therefrom, but only to the extent caused in whole or in part by negligent acts or omissions of Company.

14.0 Non-assignability

No Proposer shall assign any interest in this contract by assignment, transfer, or novation, without prior written consent of the Parish. This provision shall not be construed to prohibit the Proposer from assigning his bank, trust company, or other financial institution any money due or to become due from approved contracts without such prior written consent. Notice of any such assignment or transfer shall be furnished promptly to the Parish.

15.0

Exclusions

Pursuant to Louisiana Revised Statute 38:2227, Proposer must certify that he has not been convicted of, or has not entered into a plea of guilty or nolo contendere to public bribery, corrupt influencing, extortion, money laundering or their equivalent Federal crimes. Proposer must further certify that he has not been convicted of, or has not entered into a plea of guilty or nolo contendere to theft, identify theft, theft of a business record, false accounting, issuing worthless checks, bank fraud, forgery; Proposers' misapplication of payments, malfeasance in office, or their equivalent Federal crimes within the five (5) years prior to submitting the proposal.

16.0 Disclosure

Proposer must disclose whether it provides services or pays commissions to any employee or elected official of St. John the Baptist Parish. If so, Proposer must disclose to whom services are provided and/or commissions are paid. Both positive and negative responses must be submitted.

17.0 Termination for Cause

The Parish may terminate this Agreement for cause based upon the failure of the Contractor to comply with the terms and/or conditions of this Agreement, provided that Parish shall give the Contractor written notice specifying the Contractor's failure to perform and provide thirty (30) calendar days' notice, from mailing of the notice, to cure and/or remedy the stated non-compliance. This Agreement shall terminate thirty (30) calendar days from the date the notice was mailed.

The Contractor may terminate this Agreement for cause based upon the failure of the Parish to comply with the terms and/or conditions of this Agreement, provided that the Contractor shall give the Parish written notice specifying the Parish's failure to perform and provide thirty (30)

calendar days' notice, from mailing of the notice, to cure and/or remedy the stated non-compliance. This Agreement shall terminate thirty (30) calendar days from the date the notice was mailed.

Notwithstanding the above, the Contractor will not be relieved of liability to Parish for damages sustained by Parish by virtue of any breach of this Agreement by the Contractor.

18.0 Termination for Convenience

Parish may terminate this Agreement at any time by giving thirty (30) days written notice to the Contractor of its intent to terminate this Agreement.

The Contractor, upon receipt of such notice, shall immediately discontinue all services in connection with the performance of this Agreement and shall proceed to cancel promptly all existing orders and contracts insofar as such orders or contracts are chargeable to this Agreement.

The Contractor shall, as soon as practicable after receipt of notice of termination, submit a statement showing in detail the services performed and payments received under this Agreement to the date of termination.

The Parish shall then pay the Contractor promptly that portion of the prescribed fee to which both parties agree.

Contractor fully acknowledges that no payment will be made for any work performed or expenses incurred after receipt of the termination by either party unless mutually agreed upon in writing.

Failure to meet agreed delivery dates or authorized extensions are considered substantial failures and breach of this contractual agreement by Contractor.

19.0 Force Majeure

Contractor's performance of its obligations hereunder shall be excused in the event and during the period that such performance is prevented or rendered unsafe by the following: acts of God; acts of war, riot, accident, flood or sabotage; pandemic, unavailability of adequate staff or fuel, power or materials; judicial or governmental laws, regulations, requirements, orders or actions; injunctions or restraining orders which are ultimately determined to have been wrongfully granted; the failure of any governmental body to issue or grant, or the suspension or revocation of, licenses, permits or other approvals or authorizations necessary for the performance of the services contemplated by this agreement; or national defense requirements.

20.0 Severability Clause

If any one or more of the provisions contained in this Agreement shall, for any reasons, be held to be invalid, illegal or unenforceable, in whole or in part, such invalidity, illegality, or unenforceability shall not affect any other provisions of this Agreement, and in such an event, this Agreement shall be construed as if such invalid, illegal, or unenforceable provisions had never been contained herein.

21.0 Venue

This Agreement shall be governed by the laws of the State of Louisiana. Proper venue for any lawsuit arising under the terms of this Agreement shall be the Fortieth Judicial District Court, St. John the Baptist

Parish and any appropriate Appellate therefrom. Proposer hereby agrees and consents to personal and/or in rem jurisdiction of the trial and appropriate Appellate courts.

22.0 Discrimination Clause

The Proposer agrees to abide by the requirements of the following as applicable: Title VI of the Civil Rights Act of 1964 and Title VII of the Civil Rights Act of 1964, as amended by the Equal Employment Opportunity Act of 1972, Federal Executive Order 11246 as amended, the Rehabilitation Act of 1973, as amended, the Vietnam Era Veteran's Readjustment Assistance Act of 1974, Title IX of the Education Amendments of 1972, the Age Discrimination Act of 1975, the Fair Housing Act of 1968 as amended, and Proposer agrees to abide by the requirements of the Americans with Disabilities Act of 1990.

23.0 Licenses and Taxes

The Contractor must be properly licensed and certified by any and all regulatory agencies (Federal, State, and Local) requiring licensing and/or certification with regard to this proposal.

Repair of Submersible Pumps, Motors, and Related Equipment

Non-Federal Entity (State agency or Agency of a Political Subdivision of a State)

Termination for Cause

Should the Parish determine that the Contractor has failed to comply with the Agreement's terms, the Parish may terminate the Agreement for cause by giving the Contractor written notice specifying the Contractor's failure. If the Parish determines that the failure is not correctable, then the Agreement shall terminate on the date specified in such notice. If the Parish determines that the failure may be corrected, the Parish shall give a deadline for the Contractor to make the correction. If the Parish determines that the failure is not corrected by the deadline, then the Parish may give additional time for the Contractor to make the corrections or the Parish may notify the Contractor of the Agreement termination date.

Termination for Convenience

Either Party may terminate the Agreement at any time without penalty by giving thirty (30) days written notice to the other Party of such termination or negotiating with the Parties regarding a termination date. Contractor shall be entitled to payment for deliverables in progress, to the extent that the work is acceptable.

Contract Provisions Applicable to Projects Fully or Partially Funded by the FEMA Public Assistance Program (Note: All such terms are also applicable to all appropriate subcontractors):

a. Equal Employment Opportunity — Except as otherwise provided under 41 CFR Part 60, the Contractor and Subcontractors must comply with 41 CFR 60–1.4(b), in accordance with Executive Order 11246, "Equal Employment Opportunity" (30 CFR 12319, 12935, 3 CFR Part, 1964–1965 Comp., p. 339), as amended by Executive Order 11375, "Amending Executive Order 11246 Relating to Equal Employment Opportunity," and implementing regulations at 41 CFR part 60, "Office of Federal Contract Compliance Programs, Equal Employment Opportunity, Department of Labor."

During the performance of this contract, the Contractor agrees as follows:

(1) The Contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. The Contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, sexual orientation, gender identity, or national origin. Such action shall include, but not be limited to the following:

Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The Contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.

- (2) The Contractor will, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, sexual orientation, gender identity, or national origin.
- (3) The Contractor will not discharge or in any other manner discriminate against any employee or applicant for employment because such employee or applicant has inquired about, discussed, or disclosed the compensation of the employee or applicant or another employee or applicant. This provision shall not apply to instances in which an employee who has access to the compensation information of other employees or applicants as a part of such employee's essential job functions discloses the compensation of such other employees or applicants to individuals who do not otherwise have access to such information, unless such disclosure is in response to a formal complaint or charge, in furtherance of an investigation, proceeding, hearing, or action, including an investigation conducted by the employer, or is consistent with the Contractor's legal duty to furnish information.
- (4) The Contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the Contractor's commitments under this section and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- (5) The Contractor will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- (6) The Contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- (7) In the event of the Contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part and the Contractor may be declared ineligible for further Government contracts or federally assisted construction contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law. (8) The Contractor will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. - 9. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of a participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings
- 10. Except for transactions authorized under paragraph 6 of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency may terminate this transaction for cause or default.

EXHIBIT A Scope of Work

The Company shall provide written responses to the following requests in the same order as requests are received. The Company shall address the following requests with sufficient detail to allow the Parish to understand how your company would fulfill the Parish's needs. Only contractors with experienced, trained, professional personnel directly employed or supervised by the contractor will be considered.

Qualifications and Experience

- 1. Background
- 2. Must have been in business of waterworks and drainage pumps as well as motors repairs for a minimum of five (5) years.
- 3. Company must provide a minimum of three (3) <u>written</u> customer references for similar projects (must be letters of reference from current or prior company)
- 4. Special capabilities to accomplish assigned work

Requirements and Specifications

The following minimum qualifications have been established as a basis for determining the eligibility of a Company. Only contractors with experienced, trained, professional personnel directly employed or supervised by the contractor will be considered.

The on-site Mechanic shall be factory trained for one or more major pump manufactures. Contractor shall have the skill, knowledge, proficiency and other necessary qualifications to install, maintain, troubleshoot, inspect, disassemble, repair, rebuild, replace and reassemble any of the waterworks pumps, pump controls, motors, and right angle gear drives.

The successful contractor, herein referred to as the contractor, must have been in the business of waterworks and drainage pumps as well as motor repairs for a minimum of five (5) years.

The contractor's on-site designated mechanic must have a minimum of five (5) years' experience in the warranty repair, installation and/or startup of centrifugal, self-priming centrifugal and multistage vertical turbine cold water pumps in sizes up to at least 36 inches in diameter. Contractor must have experience as a factory trained representative for a major pump manufacturer such as Aurora, Crane Deming, Zoeller, Fairbanks Morse, Gorman Rupp, Peerless, etc. The contractor will be required to submit training documents for employees. The contractor must have available mechanics 24 hours a day, 7 days a week including holidays.

The contractor must have an available machine shop 24 hours a day, 7 days a week including holidays at their disposal. Contractor must be able to supply St John Parish with documentation to support availability of machine shop. The shop must employ full time a machinist on call 24 hours a day, 7 days a week to do any emergency work. The machinist must have at least five (5) years' experience on lathes and milling machines. The company must be equipped with at least one lathe, one milling machine and broach equipment. The shop must have all other necessary equipment such as bearing presses, drill presses, all

necessary machine tools, plasma cutting, wire feed, stick, TIG, and Heliarc welding machines for cast iron aluminum, stainless steel and steel metals with certified welders trained in the operation of this equipment and experienced in metal repair. All maintenance installations repairs or workmanship shall be performed in a responsible manner in accordance with high quality work standards that meet or exceed all warranties and manufacturer recommended procedure that assures the manufacturer honors its warranty.

The completed finished component or system must function free of excessive vibration; with motor and pump coupling to be aligned with laser alignment technology. Alignments must be performed by a qualified technician. All couplings must be aligned to within .0001 total run out. All coupling alignments must have a printed read out of final alignment number.

Only precision, high quality professional workmanship shall be acceptable. It is the objective to obtain comprehensive long-term, cost-effective preventative and demand maintenance so that the maximum useful life of the equipment can be achieved.

The contractor shall systematically examine, troubleshoot, repair, retrofit, upgrade, replace worn parts or components of equipment with new or reconditioned parts or components and install new equipment. When completed, the equipment must be cleaned, aligned, adjusted, calibrated, balanced, lubricated and all other tasks required, then tested to verify the efficient and effective performance of the component.

The contractor shall supply all necessary tools, testing devices, shop facilities, equipment, parts materials and labor to implement a thorough completion of the work in a timely, cost-efficient manner.

The contractor must stock and maintain a sufficient inventory of the recommended factory replacement parts and components for all pumps and controls to expedite maintenance service and to assure that any downtime shall not exceed a maximum of 5 working days.

The contractor must guarantee a six (6) month warranty on all repaired or rebuilt equipment and a minimum of a one-year warranty on new equipment.

All waterworks and drainage motor rewinds shall be wound with no less than a class "h" insulation rating throughout and be dipped in a class "h" insulating varnish or resin. All motors greater than 50 hp shall be given (1) additional dip and bake cycle for additional insulation and rigidity properties. All bearing shall be changed with quality grade ball bearings such as FAG, NTN or SKF. All machine work shall be done in accordance with normal motor tolerances unless otherwise instructed to do so. All motors shall be tested, and readings recorded before leaving the repair facility.

All reconditioned motors shall carry a six (6) month warranty on parts and labor, while a rewound motor shall carry a 1-year warranty on parts and labor.

Priority must be given to work under this bid to make certain that equipment downtime does not interrupt the supply of drinking water to the public. Work assignments for this bid shall be issued by the plant/drainage supervisor or his designated representative. The plant/drainage supervisor must be consulted prior to taking any equipment out of or into

service. All work must be performed in full cooperation and coordination with the waterworks/drainage operating staff to assure proper drainage and a continuous supply of drinking water to the public.

It is absolutely essential that the maintenance service be supplied promptly when needed. The assurance of continuing waterworks and drainage operations is of prime importance. The contractor must provide 24-hour service, 7 days a week including holidays. Emergency service must be prompt and effective.

The contractor shall establish the necessary quality control, inspection, and evaluation practices to ensure field performance of the replaced or repaired system achieves the design capacity for a maximum period of time.

During maintenance or repair operations, special precautions shall be taken to prevent the contamination of drinking water facilities. Precautions shall be taken to minimize contamination of the equipment being serviced and of the surrounding area.

Special care must be taken with grease or other lubricants to prevent them from contamination and to prevent them from contaminating existing facilities. All water, paint chips, sediment, dirt or foreign material accumulated in repaired equipment shall be vacuumed, discharged, or otherwise removed from the units.

Proper cleaning is necessary before any repaired equipment can be placed in contact with potable water. If necessary, in the judgment of the wastewater supervisor, such repaired or installed equipment must be disinfected according to the latest edition of AWWA STANDARD C653 by the contractor, at the contractor's expense.

The contractor shall exercise all required safety measures to conduct works in a safe manner and shall adhere strictly to all Federal, State, Parish and Waterworks safety regulations, rules, and requirements.

Safe tools and personal protection equipment must be provided for the job by the contractor. The contractor shall do everything necessary to protect the life, health, safety, and welfare of their employee, of waterworks employees, and of the public. The contractor must be familiar with the special precautions required to work in and around water treatment facilities, including the specific safety hazards associated with treatment chemicals, waterworks processes and equipment associated with a water treatment operation.

The contractor must supply **ALL** material at his cost for each individual part. The contractor must submit a copy of their vendors invoice for materials supplied. All contractors are required to maintain documentation to ensure that every effort has been made by the contractors to secure the lowest possible price for all parts and/or equipment used in this contract.

The contractor shall log in with the operator upon arrival to the job and shall log out upon completion of the job. The parish will not be responsible for travel time to a job site in excess of one hour, by the contractor's employee's or agents.
