## INTERGOVERNMENTAL AGREEMENT WITH RIVER PARISHES TRANSIT AUTHORITY RENEWAL NO. 1

This Agreement is made and entered into on this 11<sup>th</sup> day of January, 2022, between **St. John the Baptist Parish Council**, (hereinafter referred to as "**Parish**"), represented by **Jaclyn Hotard, Parish President**, in accordance with the duly passed resolution of the St. John the Baptist Parish Council and **River Parishes Transit Authority ("RPTA")**, PO Box 2444, LaPlace LA 70068, represented by **Corey Faucheux**, in accordance with the resolution attached hereto, (hereinafter referred to as "**RPTA**") under the following terms and conditions.

### RENEWAL

The "Terms" Section of the original Agreement executed on January 22, 2019, provides that "the term of this agreement is for three (3) years beginning from the date of execution through January 21, 2022, and may be renewed by the Parish President for one (1) additional year based on the mutual consent of the parties and the allocation of funding by the St. John the Baptist Parish Council."

Accordingly, the parties hereby agree to exercise their first option to renew the original Agreement for an additional one (1) year term beginning January 22, 2022, and terminating on January 21, 2023

Except as set forth in this Renewal, all terms and conditions not addressed herein shall remain as stated in the original contract dated January 22, 2019.



**RESOLUTION NO. 01-2022**

**WHEREAS;** the River Parishes Transit Authority Board of Commissioners (RPTA) was created pursuant to Louisiana Revised Statutes 48:1601 et seq as a body politic and corporate and a political subdivision of the state comprising all of the territory in the parishes of St. Charles, St. James and St. John the Baptist; and

**WHEREAS;** the RPTA was created for the purpose to "plan, design, lease (as lessee), purchase, acquire, hold, own, construct, improve, have equity in, maintain, and administer a transit system within the area, to operate same or contract therefore, and to lease (as lessor) same for operation by private parties;" and

**WHEREAS;** the RPTA is operating a public transit system in an area including St. Charles and St. John the Baptist Parishes; and

**WHEREAS;** the RPTA relies upon financial participation from its member parishes to supplement funds necessary to carry out its purpose of providing public transit; and

**WHEREAS;** St. Charles and St. John the Baptist Parishes has agreed to provide funding to the RPTA; and


**WHEREAS;** Corey Faucheux is the RPTA Board Chairperson and, as such, has the authority to execute contract agreements and all other documents on behalf of the RPTA.

**BE IT RESOLVED,** that Corey Faucheux is hereby authorized to execute agreements on behalf of the RPTA with the **Parishes of St. John the Baptist and St. Charles** for the provision of supplemental funds for public transportation for the **Parishes of St. John the Baptist and St. Charles** and/or any City with the **Parishes of St. John the Baptist and St. Charles**.






